**HAMILTON OFFERS
AMENDMENT TO
GIVE HOOSIERS A
VOICE ON
CONTROVERSIAL
ROAD PROJECT**

INDIANAPOLIS – On Jan. 12, 2026, State Rep. Carey Hamilton (D-Indianapolis) offered an amendment that would require Hoosiers to approve state funding for the Mid-States Corridor Project via public question on the November 2026 general election ballot. This comes after the Indiana Department of Transportation (INDOT) announced last week that they had to cancel over 340 scheduled projects across the state. Meanwhile, the unpopular Mid-States Corridor Project would cost taxpayers over \$3.4 billion dollars. The amendment was struck down on procedural grounds.

"Public input is key to our democracy," Hamilton said. "House Bill 1019, the underlying bill, allows Hoosiers to weigh in on judge residency requirements. Why not allow them to weigh in on pricey taxpayer-funded projects?"

"INDOT recently canceled over 340 scheduled road projects – projects in our districts that were going to make our communities safer, build better infrastructure and lower costs for Hoosiers. We didn't have enough money for these projects, but we were able to find \$3.4 billion for a project that Hoosiers do not want. Public polling has shown that the residents of communities impacted by this new highway are overwhelmingly opposed.

"Given the time-sensitive nature of this issue with INDOT seeming to rush this project through, this is a good way and probably the only way to allow taxpayers to give input on a project that may place a financial burden on their community.

"I believe that we must make investments that will lead to a strong economic future for our state. However, those investments must weigh the cost to communities, property owners and taxpayers against potential economic benefit. It is unclear whether this project will truly benefit the communities and taxpayers that will bear the cost. Before this project gets rushed across the finish line, let's ask the taxpayers directly if they approve of their money being used in this way."

The Daviess County Fair, Inc. has announced its official retirement after 75 years of operation, citing a range of challenges that made continuation unsustainable. In a Facebook post sent this morning, the organization in Elsner explained that a combination of declining community support, volunteer shortages, difficulties in securing carnival operators, and a negative environment contributed to the decision.

"After extensive discussion and careful consideration, we have made the difficult decision to retire the fair," the post read. "In recent years, the lack of community support, significant volunteer shortages, increasing difficulty securing carnival operators, and an environment where negativity consistently outweighed positive engagement made it no longer sustainable to continue responsibly." The fair has long relied heavily on volunteers and community involvement.

However, the Facebook message noted that these vital elements continued to dwindle, while criticism and complaints increased. "Unfortunately, those essential elements continued to decline, while criticism and complaints increased, often without a willingness to assist, volunteer, or support the fair in meaningful ways," the post stated. Throughout its history, countless local residents, board members, sponsors, exhibitors, and families dedicated their time and effort to ensuring the fair's success.

on the post would be turned off and confirmed that the decision was final, stating the board would not engage in further public debate. "Comments will be turned off on this post. This decision is final, and the board will not engage in further public debate regarding this matter," the message read.

Looking ahead, the fair's closure marks the end of an era, but its legacy remains embedded in the history of Daviess County. "With this chapter now closed, the legacy of the Daviess County Fair remains part of our county's history," the Facebook statement concluded. The organization emphasized that comments

that the spirit of the fair will live on through community efforts and local traditions. In the coming weeks, community members and organizations are expected to discuss ways to honor the fair's legacy and possibly develop new events that celebrate the region's history and culture.

As Daviess County bids farewell to a beloved event, the organizers express gratitude to everyone who supported it over the years.

"Thank you to those who supported the fair over the years," the Facebook post concluded. "Your support has meant a great deal to us and the community."

The future of local festivals and community gatherings remains uncertain, but the end of the Daviess County Fair marks a significant moment in the area's history.

Others echoed similar sentiments, recalling fond memories of the annual event. The fair has historically been a highlight for families and visitors alike, offering a variety of attractions, rides, and entertainment.

Organizers hope

Visitors should observe the standard practices of washing hands and covering coughs and sneezes when around others. Masks will be provided for guests by the facility.

Vaccines are currently available for flu, RSV (Respiratory

- syncytial virus) and COVID-19. Individuals should talk with their medical provider about vaccines and which ones are recommended for them based on age and other factors.
- According to the CDC, the 2025-2026 flu season is the most severe in 25 years, but Deaconess Memorial is also seeing an uptick in hospitalizations from RSV and Covid-19. Vaccines may not prevent an infection but can help with symptom management.



To the Editor,

What's next? Huntingburg's 4th Street seems to be in a state of disrepair to the extent that a business owner, Chad Brian, brought concerns over the condition of Fourth Street to the board of public works after suffering from a fall. He voiced concerns for the safety of older shoppers. Apparently, the problem is associated with the pavers and the foundations on which they lay. The cruel joke is that the city council can't come to a consensus about the required repairs. The cost seems to be the major concern.

Perhaps the issue is as simple as why did the city chose to go retro? Pavers, bricks and cobblestones are nostalgic; but, are they really practical in the 21st century? These types of street surfaces are interesting in areas with little vehicular traffic but are they practical for a heavier traveled area? No major city in the US and very few in foreign countries still use bricks or cobblestones. The ride on them is rough and there is a high level of maintenance required. This is evident by those of us who have pavers on our property as driveways, patios and walkways.

Huntingburg and Jasper entered into an inter-local agreement last fall to spend over \$100,000 to "study" the cost to take over the maintenance of US 231 from INDOT. Interesting that even before the results of this study have been published the Mayor and City Council of Huntingburg say they can't afford the repair/maintenance of a few blocks of 4th Street. Maybe that money for the study should have been put towards road repairs. It's 4th Street that attracts people to downtown Huntingburg; but, these visitors now fear they may have a slip and fall. They may chose to forego a visit to any of the shops or restaurants there.



That will not bode well for the economy of Huntingburg. Jasper should take heed as this could happen around the square as well.

Money, it's always about the money. Why do our elected leaders seem to think money grows on trees? These same leaders refuse to take a public stand on the Mid-States Corridor where the main issue is money, over \$1 billion of tax-payer's money. INDOT requires a local match of 10% for the Corridor which will be over \$100 million from the people of Dubois

County; and, this includes Huntingburg and Jasper. It's past time for all our elected leaders to state their position on the Mid-States Corridor.

The poll that was taken last month was a poll of the registered voters in Dubois County, all of Dubois County. Voters in Huntingburg and Jasper were part of the poll. What were findings? The findings were that the voters of the county are overwhelmingly opposed to the Corridor, the cost of the Corridor and to any elected public official that supports the Corridor.

Barr Reeve has demonstrated impressive performance on the road, maintaining an unblemished away record, but Loogootee has also shown resilience and recent success on their home court.



On Saturday night, the Loogootee Lady Lions played in front of another large crowd, this time in the championship game of the Graves Construction Classic hosted by White River Valley, taking on the Linton Lady Miners. Loogootee led for more than three quarters, but a late fourth-quarter surge by Linton proved decisive as the Lady Lions fell 42-34. The game opened with a putback bucket from Ava Jeffers, though Linton quickly answered to tie it at 2-2. Jeffers scored again moments later, followed by a transition basket from Lydia Hawkins off a pass from Alexis Heckard. Early foul trouble forced Jeffers to the bench, and freshman Karmen Wilson was called upon for extended minutes. Wilson delivered immediately, finishing an and-1 on a feed from Heckard to give Loogootee the lead. Traded free throws closed the quarter with the Lady Lions holding a 12-9 advantage. Linton opened the second quarter with a three, but Alaina Diamond answered, and a Sophia Toy three pushed Loogootee's lead to five. The Lady Lions struggled to score for several minutes afterward, managing just a single free throw, before a Hawkins basket snapped the drought and extended the lead back to 20-16. Linton responded late, trimming the margin to 20-18 at halftime. Diamond attacked early in the third quarter, but Linton quickly tied the game at 23-23. A pair of free throws from Heckard and another from Diamond were answered by the Lady Miners, and the quarter ended with Loogootee clinging to a 26-25 lead. The fourth quarter opened with a Linton free throw to tie the game. Heckard knocked down a clutch three to put the Lady Lions back in front, and traded free throws kept Loogootee ahead briefly. A Linton three tied the game again, and despite a Hawkins response, the Lady Miners followed with free throws and a basket to take a 35-33 lead. Diamond scored Loogootee's final point at the line, but late attempts to regain the lead fell short as Linton closed

Mendoza And Cristobal Share Unique Connection in Indiana vs Miami National Championship

(Jan. 14/Sports Illustrated)– Indiana quarterback Fernando Mendoza's father was high school teammates with Miami head coach Mario Cristobal.

In what's been a dream season for Indiana, the national championship comes with another storyline straight out of a Hollywood movie.

Indiana quarterback Fernando Mendoza's journey from two-star recruit to Heisman Trophy winner

"I've been to a lot of games there, and it's a very full-circle moment for myself," Mendoza said. "If you open Google Maps and put my address, the University of Miami campus, it's under a mile away. And I walked there, biked there, played basketball rec games in the offseason there."

"It means a lot to me, however, I think the National Championship means a lot to everybody. So I wouldn't want it any other way, on a great stage, that the Indiana Hoosiers

are going to have to compete their butt off. They're a great team and really looking forward to the opportunity." The connections don't stop there, though. Mendoza's mother, Elsa, played tennis at the University of Miami. Fernando's Heisman Trophy speech included a touching tribute to Elsa, who is battling multiple sclerosis. Fernando and his brother, Alberto, have raised over \$150,000 to help fight the disease.

Fernando's father, Fernando Sr. — now a medical director at Nicklaus Children's Health System — was teammates with Miami coach Mario Cristobal at Christopher Columbus High School in the 1980s. Cristobal recalled "awesome memories" this week about their team winning a three-way tiebreaker for the district championship.

"I think when you go to Columbus, that brotherhood is extremely strong," Cristobal said. "You know, I mean, everywhere you go, especially in town you run in -- but we have crossed

Other Miami natives on Indiana's roster include starting cornerbacks D'Angelo Ponds and Jamari Sharpe. Miami's roster features 12 such players. Fernando also views what he, Cristobal and others have accomplished at their respective schools as a point of pride for the Cuban and Latin American communities.

"It does a lot. I think it puts it in the forefront and the light, and I think we've seen Latinos in football," Mendoza said. "It's been growing, and every single year, you hear about more Latinos, like Jake Rodriguez, great Latino from Texas Tech. And I think it's just a really good path of just making football more diverse and inclusive. I think it's great. I mean, Mario Cristobal played with my dad in high school, and so I do know him. I think it's going to be a great opportunity for both teams."

Monday's national championship won't be the first time Mendoza has faced Miami, either. While quarterbacking Cal last season, Mendoza and the Golden Bears suffered a narrow, 39-38 loss at No. 8 Miami. He called it a "heartbreaking" loss, and looks forward to another opportunity.

That opportunity will come in the final game of what's been an incredible season for Mendoza. He's played his best football of late, with eight touchdown passes in two College Football Playoff games while throwing just five incompletions and zero interceptions.

Mendoza has guided the Hoosiers to dominant wins over Alabama and Oregon in the CFP, but he's also come through in clutch situations during regular season wins over Iowa, Penn State and Oregon. Through 15 games, he's thrown 41 touchdown passes to just six interceptions while completing 73% of his passes.

Cristobal recruited Mendoza out of the transfer portal this past offseason, but wound up with Carson Beck instead. And going into this matchup, he knows his talented Miami defense is up for a major challenge against Mendoza.

"The Heisman was earned and well-deserved," Cristobal said. "The type of season that Fernando has had, really they dominated just about every game. And anytime a game was close, he was a big reason why the outcome is or was what it was because of his level of play."

"I think he combines everything that you would want in an elite quarterback. He's ahead of the defense all the time. He's two steps ahead. He understands the back end, the front. He's extremely accurate, poised. He can make you pay with his feet. He can make you pay with his arm. He understands protections really well. He anticipates like no other. He really has distinguished himself as the best football player in the country this year, and it's not by accident. A lot of reps, a lot of hard work, a guy that's been a complete difference-maker for their program." Mendoza has put himself in position to be an NFL Draft pick in 2026, perhaps No. 1 overall. The Hoosiers recruited TCU transfer quarterback Josh Hoover, who has one year of eligibility, to help replace him next season. But they also have Mendoza's younger brother, Alberto, who's eligible through the 2028 season and has Cristobal's endorsement.


"[Fernando's] younger brother is going to be as good or even better," Cristobal said. "And I think if you talk to the people over there at their university and at Columbus High School, they'll tell you that. Just really tough, smart, hardworking, awesome young men that represent their families and their university really well."






